Contrary to popular belief, perfectly healthy and loveable dogs and cats are euthanized every day simply because they have not been claimed or adopted. In many cases, the organization rescues animals hours before they are scheduled to be put to sleep. these rescues give the animals an opportunity to be adopted by a loving family and a second chance at life.
